This acceptance form is valid for the Microsoft products listed below, which shall be referred to collectively herein as the "Software". Software is made available to you because the University of Saint Francis (USF) has purchased license coverage for the Software through Microsoft Campus Agreement Subscription Student Option effective June 1, 2007 through May 31, 2008. USF is extending to you the right to use the Software on one personally-owned computer. You do not own the license or the CDs, rather you are authorized to use the Software and associated media pursuant to the terms and conditions of the license(s) granted to the University of Saint Francis for the term of the University of Saint Francis' Campus Agreement Subscription. You will be required to remove the Software from your personal machine immediately upon the earlier of (a) any event, with the exception of graduation, which causes you no longer to be a student of the institution or (b) expiration of the Campus Agreement Subscription term.

If you graduate during the Campus Agreement Subscription term, the Software license will convert to a perpetual license (meaning you own the Software) as verified in your Student License Confirmation, which may be obtained from the University of Saint Francis at that time. The Student License Confirmation is proof of Software ownership.
